#### CARE AND MAINTENANCE.

- INSPECT THE FRAME FOR ANY SIGNS OF BREAKAGE OR DETERIORATION OF FRAME OR PARTS. DO NOT USE THE PRODUCT IF EXCESSIVE WEAR AND TEAR IS EVIDENT.
- DO NOT ALLOW CHILDREN TO CLIMB ON THE PRODUCT.
- USE ON EVEN AND FLAT GROUND. DO NOT PLACE IN MUDDY POSITIONS.
